## **CIRCULAR NO.72**

Sub:- Education -Technical - Career Advancement Scheme -Engineering College Faculties- Applications called for -Reg

As per the circulars read above, instructions have been issued for filing up of applications online for placement under the Career Advancement Scheme (CAS) by the faculties of various branches in the Engineering Colleges under this Department.

As per the reference (3) above, online application filing process for CAS placements of Government Engineering College faculty which was kept in abeyance is re-opened for online submission till 10.11.2023. Initially, HODs should relieve those faculty members who are transferred to another institution as well as ADD new faculty members joined in the department consequent to General Transfer. Principal should do the same in the case of HODs as the case may be. All online applications submitted earlier are now reverted back to faculty and they should resubmit the modified application to HOD. After submitting, the softcopy (pdf) of the application should be downloaded.

The Head of Department has to verify all the online applications against the originals of the uploaded certificates and documents latest by **15th November**, **2023** and has to approve it from HOD level in the portal. In the next phase Principal has to **approve** all the applications in the portal on or before **20th November**, **2023**.

Retired Teachers who were given access to CAS Portal upon their request, for submitting applications, can also now resume the application filing

process. If any Pensioner finds it difficult to login to CAS portal should mail their concern and preferences to **trainingofficer.dte@gmail.com** along with their mobile number.

Applications for which placements are due up to 28/02/2019 will be processed currently. In the case of faculties whose assessment period falls after 28/02/2019, their due date of calling applications will be announced after discussion with the Government.

Those who have any grievances like refixation, date modification and such other issues with previous placements if any, should also apply in the portal. They can apply till 30th November, 2023. In addition, they should also email their grievance requests along with proofs of previous placements to grievances.dte.cas2023@gmail.com Their applications will be considered separately and verified by a separate Selection Committee.

Following clarification regarding Past service/Experience will be followed.

1. Past Service as mentioned in G.O (Ms)No. 204/2019/H.Edn dated 29.06.2019, **section 3.1** will **only** be accepted even if the portal has provisions beyond the said clause.

{ Previous regular service, whether national or international, as Lecturer/Assistant Professor, Associate Professor, Professor or equivalent in a University, Government colleges/Aided Colleges(including leave vacancy) / Govt controlled self financing colleges, National Laboratories/defense organizations/other scientific/professional organizations controlled by the State Government or Central Government such as the CSIR, ICAR, UGC, ICSSR, ICHR, ICMR, DBT etc.}

- 2. Previous Industrial /Research experience in organizations other than those mentioned in G.O (Ms)No. 204/2019/H.Edn dated 29.06.2019 will not be considered.
- { i.e. Private Self Financing Colleges within or outside Kerala, Private Limited Organizations & MNC's will **not be** considered. }
