The centralized Valuation of answer scripts of **THSLC Examination March 2024** will be conducted from **03.04.2024 to 20.04.2024 at Pareeksha Bhavan, Poojappura,Thiruvananthapuram (South Zone) and Govt.Ganapath Model Girls HSS Chalappuram, Kozhikkode (North Zone).** The period of valuation is scheduled in two spell and the details is noted below.

Spell One from 03/04/2024 to 12/04/2024 (8 days)

Spell Two from 15/04/2024 to 20/04/2024 (6 days)

Applications are hereby invited from eligible and qualified teachers of Govt.Technical High Schools who are teaching in Xth standard in Govt.Technical Schools for the post of Additional Chief Examiner and Assistant Examiners in their respective zones. Applications duly signed in the prescribed format should be submitted to the Head of the School by the eligible teachers. Head of the School have to verify and enter the details in the applications in iExaMS portal through **SUPDNT/PRINCIPAL** Login. After submitting the details of each teacher, the print out of the same should be generated. A school level summary of application for Additional Chief Examiners and Assistant Examiners will also be available at **THSLC SUPDNT/PRINCIPAL** Login.There will be two valuation Camps. They are the following.

1.South Zone – Pareeksha Bhavan, Poojappura, Thiruvananthapuram-12.

2.North Zone – Govt.Model Ganapath Girls HSS, Chalappuram, Kozhikkode-2.

1. Through iExaMS portal, **SUPDNT/PRINCIPAL** have to submit the details of all eligible teachers for the post of Additional Chief Examiners and Assistant Examiners based on the applications received from the teachers. The teachers from the General Schools may also be selected in the absence of eligible teachers from Technical High Schools.

ELIGIBILITY CONDITIONS

- **1.** Teachers who possess a Graduation/ Post Graduation with B.Ed in the respective subject and is handling classes for the same in Xth standard in Technical High Schools during the academic year 2023-24 are eligible to submit application for valuation in that particular subject.
- **2.** All Technical School teachers who have completed a minimum of one year of service on 01.06.2023 can apply for the post of Assistant Examiner.
- **3.** Those who have completed a minimum of 15 years of service on 01.06.2023 can apply for the post of Additional Chief Examiner.
- **4.** Print out of online application Head of School should be kept in the Office.
- **5.** Particulars noted in the application regarding the period of service and number of chances the teacher has worked as Additional Chief Examiner/ Assistant Examiner in the previous years bould be verified by the Head of School with the supportive evidence such as Service Book and registers related to the THSLC examination in the school.
- **6.** Preference will be given to those teachers who have been posted and attending the invigilation duty of March 2024 THSLC Examination. During online registration, Head of Schools should mark whether the applicant had attended the invigilation duty of THSLC March 2024.
- **7.** Teachers who satisfy the eligibility conditions should submit the duly signed application in the prescribed format to the Head of School on or before **01/03/2024**.
- **8.** Online registration by Head of schools through **THSLC SUPDNT/ PRINCIPAL** Login can be done from **26/02/2024** to **02/03/2024**.
- **9.** Those who are due to retire from service on or before 30.04.2024 are not eligible for appointment either as Assistant Examiner or Additional Chief examiner.

10.The teachers against whom any disciplinary action and had been initiated in the past years or those who have received memo, notice, charge sheet etc.pending finalization of disciplinary action in connection with valuation of answer scripts in CV Camps are also not eligible to apply for valuation. Their applications should not be submitted through iExaMS on any ground.

The Examiners will be paid Remuneration as per the existing orders. They will also be paid TA and DA as per G.O (P) No.7/2016/Fin. Dated 20/01/2016. The Valuation Camp will last for 14 days. The working in the camp will be from 9.30 am to 4.30pm in normal course. Each Examiner will have to value the following number of scripts per day.

English, Social Science, Mathematics, Engineering Drawing-III -24 Scripts

Malayalam, Physics, Chemistry Biology, General Engineering,

Trade Theories, Computer Science & IT Electrical Technology, 36 Scripts Electronics (Trade Theory)

The Examiners will have to make their own arrangements for boarding and lodging, if necessary.However,there is no objection for,using the school buildings allotted by Camp Officers for the purpose for the accommodation to teachers.

INSTRUCTIONS FOR SUBMITTING ONLINE APPLICATION

Application for Additional Chief Examiner/Assistant Examiner should be submitted in the prescribed format to the Head of the School duly signed by the eligible teacher.

- **1.** It should be clearly stated in the application form whether it is for the post of Assistant Examiner or Additional Chief Examiner.
- **2.** Head of the School have to verify and enter the details in the applications in iExaMS portal through **SUPDNT/PRINCIPAL** Login (Pre-examination menu→Application for Examiner).
- **3.** While entering the PEN, minimum details will be populated in the selected fields of the application. If no data is available against any PEN or no PEN is available for a teacher, it is suggested to enter the details manually by the Head of School.
- **4.** If any editing is required after submitting the details, the same shall be done by using the EDIT button and by entering the PEN.
- **5.** After entering the details of applicants Head of School have to do the final submission by clicking the final submission button at the bottom of the application submission page in iExaMS.
- **6.** Print out of the application duly signed by the Head of School will be generated after Final Submission of all application.
- 7. No Editing will be allowed after Final Submission.
- **8.** If any teacher got selection as Assistant Examiner or Additional Chief Examiner based on the incorrect details furnished by them, their selection will be cancelled forthwith and disciplinary action will be initiated against the teacher and the Head of the School who submitted it through iExaMS.
- **9.** If sufficient applications for Assistant Examiners/Additional Chief Examiners are not received for any subject; compulsory appointment will be made from the teachers details available in iExaMS or from the list of qualified teachers furnished by the District Educational Officers concerned from the respective zone.
