**ORDER**

As per the Govt. Order read 1 above (clause 8.2), 2 non compounded advance increments shall be admissible to the persons possessing Post Graduate Degree in a professional course such as M.Tech Degree in relevant branch/discipline recognized by a statutory university at the time of recruitment to the post of Assistant Professor. As per clause 8.6, teachers who acquire ME/M.Tech Degree in a relevant branch/discipline recognized by a statutory university while in service, shall be entitled to One Advance Increment. The revised rates of these advance increments shall take effect from 1.09.2008 as per clause 4.1.

As per Govt. Order read 2nd above (clause XI), the date of provisional/ original degree certificate, by the institution concerned will be reckoned as the date of acquiring of the qualification and the benefits under this scheme will be limited to those who acquire the respective qualification on or after 01/09/2008.

As per Government letter read (3) above, the Assistant Professors who were appointed during the period from 05/03/2010 to 21/06/2013 or those who were appointed from the PSC list which came into effect before 21.06.2013 shall be granted non compounded advance increment on acquiring M.Tech qualification.

As per the letter read 4th above, the Accountant General (A&E), Kerala, Branch Office, Kottayam has informed that advance increments for acquiring M.Tech Degree have not issued to the said incumbents earlier in their service.

On Verification of the representations and Certificates, it is seen that the following faculty members (as per lists attached) are eligible for One/ Two Advance Increments. Hence the Assistant Professors as per the lists Appended to this Order are Sanctioned Advance Increments with effect from the dates noted against their names. The incumbents who acquired M.Tech degree before joining the service are eligible for 2 non-compounded advance increments and those who acquired ME/M.Tech on or after 01/09/2008 while in service are eligible for 1 advance increment. The pay on sanctioning of the Increments will be fixed

by the Accountant General (A&E), Kerala.

The Increments were sanctioned on the basis of the applications and documents submitted by the incumbents. No further change of date will be allowed under any circumstances on subsequent production of documents.

The concerned faculty members should undertake that any excess payment is found to have been made as a result of incorrect fixation on granting advance increment if any noticed subsequently would be refunded by them to the Government without raising any objection to it.
