- i. The Head of Departments shall monitor the progress of the scheme and ensure timely implementation of projects strictly complying to the existing procedures, rules, regulations and especially following the Store Purchase / IT purchase rules.
- ii. The implementation agencies/ Departments should also prepare a schedule to complete the project and send progress reports to the Government on expenditure and physical achievements on a quarterly basis.
- iii. The Head of Departments /Institutions shall hold monitoring meetings to review the implementation of the approved schemes and shall send a progress report to the Government in due course.
- iv. It should also be ensured that the Utilization Certificates pertain to all schemes are submitted in time.
